Information coming to the website on the Alexander Kreiglowa Navy & Marine Corps Dependents Education Foundation Scholarship Application for 2020.

To be eligible for the scholarship you must be:

- Dependent child of an active duty, retired, or deceased Naval Service (USN or USMC) resident in the state of California,
- Graduating High School Senior in the top 10% of class, if school ranks, or have a 3.6 cumulative GPA or higher (unweighted grades),
- Provide evidence of acceptance for Fall 2020 by an accredited 4-year college or university in the United States

ON THIS DATE IN...

JANUARY

Jan 1, 1946 – The U. S. Coast Guard, which had operated as a service under the U. S. Navy since 1 November 1941, was returned to the control of the U. S. Treasury Department.

Jan 1, 1950 – Mary T. Sproul is commissioned as the first female doctor in the U. S. Navy.

Jan 1, 1962 - Navy SEAL teams are established.

Jan 3, 1944 – CDR Frank Erickson USCG, flew plasma in a Coast Guard helicopter from Brooklyn to a hospital in Sandy Hook, NJ in the first recorded lifesaving flight conducted by a rotary-winged aircraft.

Jan 5, 1965 – George M. Silver became the first man to be commissioned in the Navy Nurse Corps.

Jan 6, 1916 – The first enlisted flight training class commences at Pensacola, FL.

Jan 10, 1956 – Establishment of the first Navy nuclear power school at Submarine base, New London, CT.

Jan 10, 1995 – The Pentagon announced that 2,600 U. S. Marines would be deployed to Somalia for Operation United Shield to assist in the withdrawal of UN peacekeeping troops.

Jan 12, 1923 – Title "Commandant" was authorized for the service head of the Coast Guard.

Jan 15, 1974 – The first group of women ever enlisted as "regulars" in the U. S. Coast Guard began their 10-weeks of basic training at the Coast Guard Training Center in Cape May, NJ.

Jan 16, 1944 – Lt. Stewart Graham became the first person to make a helicopter take-off and landing aboard a ship (SS *Daghestan*) underway.

Jan 16, 1991 – Operation Desert Storm, the liberation of Kuwait from Iraq, begins.

Jan 18, 1911 – The first aircraft landing on board a ship, USS *Pennsylvania* by Eugene Ely.

Jan 20, 1914 – School for naval air training opens in Pensacola, FL.

Jan 21, 1918 – The 1st Aeronautical Company arrived at Ponta Delgada, Azores, for anti-submarine duty, becoming the first completely equipped American aviation units to serve overseas in World War I.

Jan 21, 1954 – The launching of the first nuclear submarine, USS *Nautilus*, at Groton, CT.

Jan 22, 1969 – Operation Dewey Canyon, perhaps the most successful high-mobility regimental-size action of the Vietnam War commences.

Jan 25, 1856 – Marines and seaman for the U. S. sloop *Decatur* went ashore at Seattle, WA to protect settlers from Indian raids.

Jan 27, 1945 – Commissioning of USS *Higbee* (DD-806), the first U. S. Navy Ship named after a woman member of the U. S. Navy (Chief Nurse Lenah S. Higbee).

Jan 27, 1973 – Paris Peace Accords signed, ending U. S. participation in the Vietnam War.

Jan 31, 1961 – LCDR Samuel Lee Gravely, Jr. becomes the first African-American to command a combat ship, USS *Falgout*.

Jan 31, 1981 – The era of Enlisted Naval Aviators ends when the last pilot, ACCM Robert K. "NAP" Jones, retired.

REAR ADMIRAL T. WEBER COMMANDER, NAVY MEDICINE WEST DIRECTOR, MEDICAL SERVICE CORPS

Rear Admiral Timothy Weber is a native of Holland, Michigan. He earned a Bachelor of Business degree from the University of Notre Dame, Notre Dame, Indiana, and a Master of Science degree from the Naval Postgraduate School. He received his commission as an ensign in 1989.

Operationally, Weber completed a one-year assignment in 2010 to the NATO Training Mission-Afghanistan/Combined Security Transition Command as Chief, Afghan National Police (ANP) Medical Advising Team/Advisor to the ANP Surgeon General. He has also served in senior staff positions as director of manpower resources, Medical Resources, Plans and Policy (OPNAV N931); legislative liaison, Secretary of the Navy's Office of Legislative Affairs; various healthcare resourcing roles at the U.S. Navy Bureau of Medicine and Surgery; and chief of staff, TRICARE Management Activity, Office of the Assistant Secretary of Defense for Health Affairs.

Additionally, he has served as the director for administration, Naval Hospital Camp Lejeune, North Carolina and as executive officer, U.S. Naval Hospital Yokosuka, Japan. In 2015, Weber assumed command of U.S. Naval Hospital Okinawa, Japan. Weber's most recent assignment was at Navy Medicine West where he reported as chief of staff in 2017. He currently is the 19th Director of the Medical Service Corps.

His personal decorations include the Defense Superior Service Medal,



Legion of Merit (2 awards), Defense Meritorious Service Medal, Meritorious Service Medal (5 awards), Navy Commendation Medal (3 awards), and the Navy Achievement Medal (2 awards). He also has been awarded the Japanese Defense Cooperation Award (Second Class) from the Japan Maritime Self-Defense Force.

CAPTAIN TIMOTHY J. SLENTZ UNITED STATES NAVY COMMANDING OFFICER NAVAL BASE CORONADO

Captain Tim Slentz is a native of Dayton, Ohio, the birthplace of aviation, and is a 1993 graduate of the University of Notre Dame. He was designated a Naval Aviator in July 1996.


His seagoing assignments include service in Carrier Airborne Early Warning Squadron (VAW) 124, VAW-125, VAW-121, and Carrier Strike Group FOUR.

While serving as the Commanding Officer of VAW-121, the Bluetails earned both the Battle "E" and the RADM Fred Akers Award in recognition for being the premier VAW squadron in the Navy.

Captain Slentz's shore assignments have been at VAW-120; the United States Naval War College; Headquarters, United States Africa Command in Stuttgart, Germany; Navy Installations Command, as the Executive Assistant to the Commander; and Executive Officer of Naval Base Coronado.

He earned a Master of Arts in National Security and Strategic Studies from the Naval War College, as well as a Master of Science in Management from Troy University. He also completed an Executive Certification in Business Administration from the Mendoza College of Business.

Captain Slentz was named the E-2C Hawkeye Pilot of the Year in both 2000 and 2003 and was honored with the



Naval Air Forces NAVY AND MARINE ASSOCIATION Leadership Award in 2005 and 2011. He is a graduate of the Executive Energy Leadership Institute program at the National Renewable Energy Laboratory in Golden, CO. In April, 2018, he completed the San Diego civic leadership program INFLUENCE.

Captain Slentz has accumulated over 4,300 flight hours and 440 carrier-arrested landings. He is a recipient of the Legion of Merit, Defense Meritorious Service Medal, Meritorious Service Medal, Strike/Flight Air Medal, Navy Commendation Medal, and numerous unit commendations and awards.


